

**TOWN OF ARMSTRONG CREEK

Snowplowing Contract**

- A) A contract with the town of Armstrong Creek must be signed by the owner or occupant, giving the town permission to enter upon his or her land and waiving redress for any damages caused.
- B) All contracts must be signed, and all fees paid before Nov. 1st each year to save on collection costs. Owner or occupant must pay the town the sum of \$120 for private driveways of 200 feet in length or less, \$160 for private driveways longer than 200 feet and \$175 for driveways 500 feet in length. The fee for all senior citizens 65 years and older will be \$100, and for all businesses the fee will be \$150. Any late payments will result in an extra \$10 charge, *but no requests for plowing will be accepted after December 1st.*
- C) Anyone desiring his or her driveway plowed as a special one-time service must also sign a contract. The charge for this service shall be \$50 per hour; with the time to start upon leaving the garage and to stop upon returning to same.
- D) The owner or occupant is responsible for clearly marking with reflective markers any area that could cause problems for the plow (septic systems, drywells, steps, etc.).
- E) The town snowplow will not plow any driveway or plow around any buildings unless there is at least a five foot clearance on all sides of the snowplow.
- F) No driveways will be plowed unless there is a 12-foot clearance from overhead obstructions such as trees, wires, etc.
- G) The town reserves the right to refuse snowplowing on any driveway it deems in such condition as to render it unsuitable for its equipment. The town will not be liable for damage to driveways (gravel or blacktop), lawns, and yards.
- H) State statutes require the town to plow town roads first; therefore, the plowing of driveways will be completed as time allows.
- I) After road limits are in effect, the town will not plow any driveways unless a request is made to the road boss, town chairman, or supervisor.
- J) Generally town plows will go out if there is a snowfall of approximately 3" or more, however, the decision to plow will be left up to the discretion of the Town Board.
