REGULAR TRASH

- **HOUSEHOLD WASTE**
- **NON-RECYCLABLE GLASS** such as light bulbs, dishes, and ceramics
- **PLASTIC** oil bottles; **Styrofoam**; hard plastic; plastic film; **ALL** plastic bags
- **MISC:** Carbon paper; cellophane; cloth; cork, foil; candy wrappers; napkins; photographs and fiberboard; cardboard-sided cans

RECYCLABLE

- Clean **GLASS** bottles and jars
- **PLASTIC** containers labeled #1, #2 & #5 (**ALL OTHERS ARE REGULAR TRASH**)
- **PAPER PRODUCTS:** newspapers; magazines; cardboard (break down boxes into pieces no larger than 3' x 5') (**NO** shredded paper)
- **METAL** cans*; clean aluminum foil; empty aerosol containers; pots & pans; utensils
- **LARGE METAL & ELECTRONICS (west end):** Appliances, radios, stereos, tools, steel, iron, brass, copper, and sheet metal (**NO REFRIGERATORS; FREEZERS OR A/C UNITS**)
- **YARD WASTE (east end of gravel pit):** Grass, leaves, branches

NOT RECYCLABLE PLACE IN REGULAR TRASH

- **TO-GO CONTAINERS AND PIZZA BOXES WITH GREASE STAINS**
- **SHREDDED PAPER**
- **BATHROOM WASTE INCLUDING DISPOSABLE DIAPERS**
- **PLASTIC BAGS OF ANY KIND**
- **STYROFOAM**

- Tires
- Syringes
- Refrigerators, freezers, A/C units
- Construction materials such as concrete, concrete blocks, bricks, windows, doors, framing materials, and roofing materials
- Lawn furniture, oil, solvents, and liquids

ALL construction/building material waste should go to GFL Environmental, Norway, MI for disposal- they have site to accept these items
